
Common Challenges Post-Release

in North Carolina

Having a criminal record can affect your ability to meet your basic needs after release. Certain policies and discriminatory practices can create barriers to re-entry for formerly incarcerated people in North Carolina (NC). This resource lists information to help you navigate those barriers in NC.

Housing

Finding affordable housing after incarceration can be difficult, but there are housing coordinators that can help you if you are not staying with family or friends.





Employment

Finding a job after incarceration can be difficult because some laws automatically exclude you from certain jobs or obtaining certain licenses needed to work.

Employers are not allowed to ask about your criminal record on job applications or during an initial interview, but they can ask about your criminal record after the interview and use their discretion in hiring. Employment coordinators can help you understand your rights and find jobs that you are qualified for.



Nutritional Assistance

Some people have trouble affording groceries after release. Also, NC law prohibits formerly incarcerated individuals who received a controlled substance felony from receiving benefits through the Supplemental Nutrition Assistance Program (SNAP) and Temporary Assistance for Needy Families (TANF) programs. However, there are exceptions.

Depending on your criminal record, you may be eligible for assistance under the SNAP and TANF programs. SNAP and TANF coordinators can help you with your specific situation.



Healthcare

Depending on your health insurance status before incarceration, you may need to restart insurance when you are released. There is a special 60-day enrollment period following release when you can sign up for health insurance coverage.

If you are eligible for Medicare following release (e.g., if you are 65 years or older), you may be able to start or resume coverage following release.

If you do not have health insurance, there are still programs that can help you access medical care for free/reduced cost after release.



Social Security

If you are currently receiving Social Security disability or Supplemental Security Income (SSI), these benefits are suspended for most people who are incarcerated.

You may be able to restart benefits following release. The amount of time you have to wait before re- starting depends on your situation. There are people who can help you check to see if you are eligible for social security after release, and help you apply.
